It is agreed that the title to said property and any additions thereto or substitutions therefor is to remain in the distributor and assigns until all amounts due hereunder are paid in full. Time is of the essence of this agreement, and if the distributor or assigns deem themselves unsecure for any reason or if the purchaser fails to make any installments as above specified, all remaining installments may be declared immediately due and payable. In the event of the non-payment of any such installment when due, the purchaser agrees to return the said property and any additions thereto to the dealer or assigns, who may make such disposition thereof as may be deemed desirable, and all payments previously made shall be retained by the distributor or assigns as liquidated damages for the use of said property. The distributor or assigns shall not be required to retake possession or accept the return of any such property, but may proceed against the purchaser and effect collection of the balance then remaining unpaid upon the total purchase price hereinbefore stated. In the event the distributor or assigns employs an attorney to enforce the purchaser's obligations hereunder, the purchaser agrees to pay an additional amount equal to 10% of the unpaid balance as and for attorney's fees. The waiver of any default by the distributor or assigns shall not constitute a waiver of future defaults. The purchaser agrees that, if the distributor assigns this agreement, the assignee's rights shall be independent of any claim of the purchaser against such distributor. The purchaser further agrees to take all reasonable care of the property and any additions and to be responsible for its loss or damage by fire, theft, or other casualty. It is understood and agreed that all rights and remedies hereunder are cumulative and not alternative and are in addition to and not in substitution for any rights and remedies given by the law. Any part of this agreement contrary to the laws of any state in which the same shall be made shall not invalidate any other part of this agreement. The purchaser hereby certifies that the statements on the reverse side of this contract are true and are made for the purpose of obtaining credit from the distributor.

IT IS UNDERSTOOD AND AGREED THAT NO OTHER AGREEMENT, GUARANTY OR WARRANTY, VERBAL OR WRITTEN, EXPRESSED OR IMPLIED, SHALL LIMIT OR QUALIFY THE TERMS OF THIS CONTRACT.
